

#### RULES, REGULATIONS & GUIDELINES


- 1. The V.C.C.I. reserves all rights, to amend/alter/make change/in the terms and conditions.
- 2. In these Rules and Regulations, the "EXHIBITOR" shall include all employees, staff and agent of any company, partnership firm or individual to whom space/stall has been allocated for the purpose of participation.
- 3. No exhibitor will be allowed to change the exterior layout, paint the interior, or change the standard format for the company's name banner. No painting or touching will be permitted at the exhibition under any circumstances. Removal of partition between stalls is not permitted. Exhibitors, who violate this rule and cause damage to any property including the furniture, fitting, frame etc. of the premises, will be liable for penalties & damages.
- 4. Amount for damages/loss of the stall material, if any, and any other amount debited to participants account will be deducted from the DEPOSIT. Balance amount will be refunded to participants within 30 days from the close of the event.
- 5. No Alteration to the size or position of an Exhibitor's stall is permitted. No poster or banner may be put outside the stall. The Exhibitors may not assign, sub-let or grant licenses in respect to the whole or any part of the stalls. Cards, advertisement or printed matter of persons or firms who are not bonafide Exhibitors will not be exhibited or distributed from any stall except that an exhibitor may distribute cards, advertisements or printed matter in respect of companies or firms which are subsidiary of Exhibitors or the Exhibitors ultimate holding company.
- 6. Inflammable material will not be allowed inside the exhibition area. The use of naked flame or a direct/indirect heating appliance is totally banned.
- 7. Creating any nuisance like playing music, which may disturb other participants, is strictly prohibited.
- 8. No refund will be made under any circumstances against cancellation/withdrawal of stall/stalls once booked. Joint participation or transfer or subdividing or subletting of the booked stalls to third party is strictly prohibited. In case the exhibition is postponed, participants will be given an opportunity to participate in the events of the new dates. Further, the organisers are not liable for any change in the names or dates arising from circumstances that are beyond their control nor any refund will be made to Exhibitors in respect thereof.
- 9. All Exhibitors shall insure their machinery, goods etc. kept in the stalls, at their cost, against all damages from fire, theft, strikes, floods, storms, earthquake etc. for the entire duration of exhibition and also during the construction and dismantling period.
- 10. All on-site electrical installations must be carried out by the officially appointed electrical contractor before the connections to the main supply.
- 11. The organisers will use their best endeavours to ensure the supply of services of MGVCL., VMSS., etc., and of those supplier mentioned in the manual, but as the supply of such services are not within the control of MGVCL., VMSS., etc neither they nor the organisers shall incure liability to the Exhibitor for any loss or damage, if such services shall wholly or partially fail or cease to be available. - 13. The removal of exhibits will be allowed only after all the dues have been paid and relevant clearance certificate obtained.
- 14. The organisers will in no way be responsible for damages caused to the property of the Exhibitors or their staff members and visitors due to any reason whatsoever.
- 15. No material once exhibited will be allowed to be taken outside the exhibition premises without prior permission.
- 16. No vehicles will be allowed in the exhibition ground during exhibition timings. Goods must be delivered to the stalls, hour before the opening and removal one hour after the closing of the exhibition. During this period before exhibition, card with permits only will be admitted to the ground. To prevent congestion at the exhibition site, all vehicles must use parking area provided outside the exhibition ground.
